1. WHO WE ARE

Stichting Preferente Aandelen Arcadis N.V. (the "**Preferred Stock Foundation**" or "**Foundation**" or "we" or "us") has been founded in 1995 in view of the listing of the shares of Arcadis N.V. (the "**Company**") at Euronext in Amsterdam. At that time the Foundation was called Stichting Preferente Aandelen Heidemij Holding N.V. In 1997 its name was changed into the current one. The Foundation is the data controller of the personal data collected as set out in this privacy statement. In this privacy statement we explain how we collect and use personal data when you visit our website (www.pref-foundation-arcadis.com) or when you contact us.

The objectives of the Preference Shares Foundation are to represent the interests of Arcadis N.V., its affiliated enterprises and its stakeholders. It seeks to achieve its objectives by, *inter alia*, acquiring cumulative preference shares.

2. THE TYPES OF PERSONAL DATA WE PROCESS

We may collect and process the following categories of personal data:

- <u>Information you provide</u>: when you visit our website, your IP-address is registered.

3. FOR WHICH PURPOSES WE USE YOUR DATA

We may also be required by law to share your personal data with public authorities, governmental organizations or law enforcement for the purpose of compliance with legal obligations.

5. SECURITY AND RETENTION

We will take appropriate technical and organizational measures to protect your personal data against loss or unlawful use.

Your personal data will be retained for as long as required for the purposes described in this privacy statement or in so far as such is necessary for compliance with statutory obligations and for solving any disputes.
